01. Essential Qualifications & Requirement

- Bachelor's degree (B.Tech or BE) in branches of Mechanical, Civil and Electronics & Communication engineering, from an institution recognized by AICTE / NAAC or affiliated to an Indian / Global University of repute or equivalent, with minimum 65% aggregate score / percentage obtained.
- Applicants with GATE (Graduate Aptitude Test in Engineering) scores obtained between 2022 to 2024 in the aforesaid branches, shall be considered.
- Candidate belonging to General / EWS category and candidates belonging to SC / ST / OBC (NCL) / PWD applying against **Unreserved Posts** - should have first class degree / minimum 65% marks in Minimum Qualification for consideration against unreserved posts.
- Reserved category candidates (SC / ST / OBC-NCL / PWD as applicable) should have at least 55% marks in Minimum Qualification for consideration against reserved posts.

02. GATE Examination Criteria

- Interested candidates fulfilling the eligibility criteria should have appeared for GATE examination in the calendar years of 2022, 2023 & 2024.
- Candidates obtaining valid Marks (Normalized Marks out of 100) shall only be eligible for the next stage of selection. The Marks will be valid only if the candidate obtains more than or equal to the Qualifying Marks, as fixed for GATE - 2022/23/24 papers (as applicable).
- Qualified candidates shall be short-listed category-wise for Interview based on their Normalized Marks (Out of 100) in the corresponding papers of GATE 2022/23/24.
- Candidates shortlisted for Interview shall be required to submit the documents as may be mentioned in the call letter.

- Only those candidates shall be considered for empanelment, who secure a minimum of 60% marks in Interview. There shall be no qualifying marks required in aggregate.

- The candidates will be screened based on the data furnished in the online application form. At the time of the interview, all the original documents are verified to confirm the eligibility. At this stage, if it is found that the candidate has furnished false information in online application or failed to produce the documents in support of his/her eligibility, their candidature shall not be considered for personal interview.

03. Important Information for Reservation based Applicants

- A candidate will be eligible to get the benefit of community reservation only in case the particular caste to which the candidate belongs is included in the list of reserved communities issued by the Central Government.
